

## **Band of the Hour – Hall of Fame**

### **Purpose:**

The University of Miami Band of the Hour Association of Alumni and Friends established a Hall of Fame to identify and honor, in a permanent manner, those individuals who have achieved excellence in performance and/or musicianship, in the Band of the Hour or who have contributed to the advancement of the Band by support in time, resources or talent.

### **Eligibility:**

Individuals who shall be designated as eligible for Hall of Fame honors are those who have:

- Achieved excellence in the Band of the Hour, at the University, for a period of at least two academic years and have been officially disassociated as a student for a period of at least ten years.
- Advanced and enhanced the concept of the Band at the University, through their talent as directors.
- Contributed to the advancement of the Band of the Hour and are not classified as students or music directors and who may or may not have matriculated at the University of Miami.

### **Nominations:**

\* Nominations may be made only by Band of the Hour Association of Alumni and Friends members who are current with their BOTHA membership dues and have been a member of the University at least one academic year, either as a student or faculty.

\* Nominations shall be made on the form provided below or by letter, provided this type of nomination includes reasonable justification for the nomination. Forms may also be provided on our web site at [www.BOTHAonline.com](http://www.BOTHAonline.com). Go to the Hall of Fame link.

\* Deadlines will be posted on the web site and in the newsletter correspondence.

\* All forms will be forwarded to the chairman of the selection committee.

### **Selection Committee:**

A selection committee shall be appointed by the President of the Band of the Hour Association each year.

Induction:

\* Annual induction of honorees shall be made during the Homecoming ceremonies.

\* A reception for the honorees will be held at an appropriate time during Homecoming.

\* No more than three honorees will be inducted in any given year.

\* Each honoree shall be presented an appropriate plaque descriptive of the honor.

\* The activity time line, content, and other plans related to the induction, shall be, with the guidance of the Board of Directors, determined by the Committee.
